_____ CORI Certification Letter – required for all organizations servicing youth under 18 years of age indicating that all Coaches and Assistant Coaches are CORI certified.

_____ Team roster with players names, address and phone numbers.

_____ List of all coaches names, addresses and phone numbers.

_____ The Recreation Department requires a Certificate of Insurance naming the Town of Tewksbury as an additionally insured. The Town of Tewksbury requires all groups that use the parks, athletic fields or other facilities owned by the Town to show proof of insurance.

- The General Liability Insurance shall at a minimum be in the amount of \$1,000,000 single and \$3,000,000 aggregate.
- Insurance Certificate must be submitted annually with Permit application.
The Town of Tewksbury requires all groups that use the parks, athletic fields or other facilities owned by the Town to show proof of insurance.
- The Town of Tewksbury Recreation Department shall be listed as the Certificate Holder.
- The Insurance Certificate must be submitted annually with Permit application.
- (The Town may waive or adjust these requirements if deemed in the Town’s Interest)

_____ Camps must be approved by the Town Board of Health and a certificate attached.

_____ Signed acknowledgement of Tewksbury Recreation field/facility policies and procedures.

As a condition of use the permit holder agrees to furnish at their own expense, Police or other protection, if deemed necessary by the Town Manager or his/her duly appointed designee, and to reimburse the Town of Tewksbury for any damages done to the site.
